It's no secret that labor is a huge issue in agriculture. According to the WCO annual survey, members cite labor as one of their primary challenges. Despite this challenge, there are countless men and women employed by custom farming operations who make significant contributions to your team.

Each year, WCO honors an employee of a custom farming operation who demonstrates excellence in the areas of safety, efficiency, customer service, environmental stewardship and profitability. This award is particularly focused on acknowledging and recognizing member-employee contributions that are beyond the normal job expectations.

All employees, both full-time and parttime, of a WCO member-business are eligible for the award. The individual must have been employed by a WCO member during the last calendar year prior to the award year. The winner will receive \$750 and the nominator will receive \$250.

"Many of our members have had the same crew for several years. These employees are highly skilled and keep our businesses going during the height of the season," said Bryce O'Leary, WCO president. "Their commitment to safety, the environment and our clients is outstanding – and this award is our opportunity to honor them."

Policy Center issues to watch

Department turnover

In September, DNR Secretary Cathy Stepp resigned to take a presidential appointment with the Environmental Protection Agency. Gov. Walker appointed former legislator Dan Meyer to take her place.

In July, DATCP secretary Ben Brancel announced his retirement. Gov. Walker is expected to announce his replacement in November.

NR 151 - Runoff Management

This rule has been revised to include targeted performance standards for the eastern side of the state in areas with Silurian Dolomite topography.

State Budget

In September, Gov. Walker signed the \$76 billion budget that includes \$402 million of borrowed funds for roads but does not increase the gas tax.

Despite wet spring, excellent season overall

With his dad, Gary Halopka, working as a custom operator, Casey Halopka always knew he wanted to get into custom work. In 2012, Casey purchased half of the equipment from his dad and later his brother. Adam Halopka, bought the other half, making Casey and Adam Halopka co-owners of the business. Originally, Halopka Field Services, located in Dorchester, Wis., provided services ranging from chopping to corn planting to manure hauling. The increased demand for manure hauling led the Halopka brothers to specialize in custom manure hauling. Today their operation includes draglines, semis and tractor tankers.

Like most farmers and custom operators, the rain this spring was a huge challenge for Halopka Field Services. "We actually did well for how bad the season was this spring," says Casey. "We worked hard and when we finished, we looked at each other and thought 'how did we do this'?"

Being stopped on the road with large equipment (mostly in Marathon County), has caused issues for Halopka Field Services in the past, but they haven't had any trouble for the past two years.

"With the road regulations, we switched to more semis and hoses, so we are on the road less than we were before," said Casey. "This spring went really well, and I hope it will continue to go well during future seasons."

During the interview, Casey commented that they just built a break room this past winter. "I never would have dreamt of having two shops and a break room. And this building isn't even our big shop," he said.

"If you would have asked me if I wanted to expand last fall, I would have said 'no way in heck'. But after how well things went this spring, expanding is definitely a consideration for the future."

Halopka Field Services hauls 250 million gallons of manure a year, with

forty percent of hauling done in the spring and sixty percent done in the fall. With a range of 150 miles, Halopka Field Services keeps busy and this past season even had to turn down jobs. "The jobs are there, and it's for us to get it done," said Casey.









On the morning of August 15, 2016 the Biadasz family received the worst news anyone can receive. Mike Biadasz, loving son, brother and uncle tragically lost his life while agitating a manure pit on his farm. He had succumbed to hydrogen-sulfide gas. In the wake of tragedy, Mike's family turned their grief into action.

This program will provide rebates for farmers and manure haulers who rent gas monitors, protecting them, their workers, and their family from the hazards of manure gas. Four-gas hand monitors are expensive to purchase and require calibration every 3-4 months to ensure it is working properly. Calibration can also be expensive. This program allows you to rent the right equipment at a reduced cost.

How the program works:

- Rent any four-gas monitor, up to 5 monitors per operation
- Use it to protect you, your workers, and your family

 Mail in the rental receipt and the completed Rebate Form

Those who mention the Mike Biadasz Manure-Gas Monitor Rebate Program will receive special pricing from Premier Safety, Inc. (call 586-840-3204). If you place your rental order by 2:00pm central time it will ship that day and arrive the next day. The rental will start the day you receive the monitor(s). You are not obligated to use our preferred vender, but any rental must be from a legitimate gas monitor rental company (not from another individual). This is to insure that the devise is working properly and is calibrated.

Benefits of Participating in the Program:


- Receive a \$75.00 rebate after the rental of a four-gas monitor

Eligibility:

- You must be a Wisconsin farmer or manure hauler
- The rented monitor(s) must be a four-gas model
- Rebates are not applicable to the purchase of any gas monitor
- Monitors maybe used for other farm use (ex: silos, grain bins, bunkers)
